

SCHOOL ELECTIONS CALENDAR 2015

DEADLINES	TIME	EVENT
DECEMBER 21 THRU MARCH 26		TRUSTEE CANDIDATES FILE FOR ELECTION. NOMINATION PETITION AND OATH OF CANDIDACY MUST BE FILED WITH ELECTION ADMINISTRATOR. NO PERSON SIGNING A PETITION MAY SIGN MORE NOMINATION PETITIONS THAT THERE ARE TRUSTEE POSITIONS OPEN. NO CANDIDATE MAY APPEAR ON THE BALLOT UNLESS HE OR SHE MEETS THIS DEADLINE. <i>CANDIDATE MUST BE REGISTERED TO VOTE AT THE TIME THE PETITION IS FILED.</i>
March 27		LAST DAY TRUSTEE CANDIDATES CAN WITHDRAW FROM THE ELECTION. ANY CANDIDATE THAT HAS ALREADY FILED FOR ELECTION, BUT WISHES TO WITHDRAW THEIR NAME MAY DO SO BY SENDING A STATEMENT OF WITHDRAWAL TO THE ELECTION ADMINISTRATOR.
MARCH 31		LAST DAY TO FILE RESOLUTIONS FOR SCHOOL ELECTION WITH COUNTY ELECTION ADMINISTRATOR.
APRIL 3		DEADLINE TO NOTIFY ELECTION JUDGES OF APPOINTMENT
APRIL 5 THRU APRIL 15		NOTICE OF ELECTION IS POSTED
APRIL 6		VOTERS REGISTRATION CLOSSES. A VOTER MUST REGISTER BY THIS DEADLINE TO VOTE IN THE SCHOOL ELECTION.
APRIL 9	5:00 P.M.	DEADLINE FOR WRITE-IN CANDIDATE FOR A TRUSTEE POSITION ON A SCHOOL BOARD TO FILE DECLARATION OF INTENT.

APRIL 10	ELECTION BY ACCLAMATION AND CANCELLATION OF ELECTION NOTICE- IF THE CANDIDATE FILING IS EQUAL TO OR LESS THAN THE NUMBER OF OPEN TRUSTEE POTITIONS TO BE ELECTED THE TRUSTEE'S CANCEL THE TRUSTEE ELECTION	
APRIL 15	ABSENTEE BALLOTS AVAILABLE	
MAY 4	NOON	DEADLINE FOR ABSENTEE BALLOTS REQUESTS. VOTERS WHO WISH TO VOTE ABSENTEE MAY REQUEST AN ABSENTEE BALLOT IN WRITNG OR IN PERSON UNTIL NOON THE DAY BEFORE THE ELECTION
MAY 5	ELECTION DAY	
MAY 20	TRUSTEES CANVASS THE VOTES, ISSUE CERTIFICATES OF ELECTION, AND PUBLISH RESULTS	
May 11 THRU MAY 25	DEADLINE FOR FILING A PETITION FOR RECOUNT	
JUNE 1	DEADLINE FOR TRUSTEE TO REQUEST COUNTY ELECTION ADMINISTRATOR TO CONDUCT SCHOOL ELECTIONS FOR NEXT YEAR	
JUNE 4	CANDIDATE COMPLETES AND FILES OATH OF OFFICE
